**2. HOW TO ENTER:** Post a photo of your plate from one of the participating Dine Around Downtown restaurants at Dine Around Downtown to Instagram on May 21, 2019. All photos must be geo-tagged at 28 Liberty Plaza and must be posted between 11am-11:59pm on May 21, 2019 using the #DOWNISWHATSUP. Multiple entries are allowed. If you do not have access to Instagram and wish to participate, you may submit a photo via email between 11am-11:59pm on May 21, 2019 to [dinearounddowntown@downtownny.com](mailto:dinearounddowntown@downtownny.com).

Each entry has an equal chance to win. Any dispute regarding submission of an entry will be deemed submitted. Sponsor, in its sole discretion, reserves the right to disqualify any person tampering with the entry process. The Downtown Alliance is the sole authority for this Contest.
